To have the right to vote, the member must have reached the age of 15, been a member of the sports team for at least one month, and have paid the membership fee. Pursuant to section 15 of the NRF Act, the following meeting may have the right to vote at the foundation meeting

15.1 At the Federal Parliament meetings with the right to vote:

- a. The Federal Government
- b. Elected representatives from the clubs according to the regulations of the parliament.
- c. Club representatives attend the meeting according to the following distribution

(in relation to the figures that appear in the sports registration / NIF):

Clubs with 50 members or less: 1 repr.

Clubs with 51 - 150 members: 2 repr.

Clubs with 151 members or more: 3 repr.

15.2 The representatives must be elected at an ordinary or extraordinary annual meeting / thing in the clubs, or appointed by the club board by authorization of the annual meeting.

15.3 The board determines how much of the representatives' travel expenses are to be covered by the special union. Travel expenses distribution can be used.

15.4 Further meetings without voting rights:

- a. Chair of the professional committees, possibly deputy chair or board member if the chair is prevented from attending
- b. Members of the Control Committee
- c. Members of the Nomination Committee
- d. Auditor

15.5 Further meetings without the right to vote, but with general right to speak and make proposals:
- Secretary General - Employee representative
